Resolution on Annual Fee Payment IAPSS General Assembly, Amsterdam 2006

Affirming once more that the Annual Fee is indeed a permanent reminder to the members that they are part of IAPSS, therefore of the IAPSS community
Believing that our community strives to promote positive interaction, understanding, solidarity and development among students worldwide

Observing that our Member Associations have different opportunities according to economical background of the country where the associations are located

We accept to diversify the Annual Fee Payment for the Association Members based on their country of origin

The country classification should follow the World Bank's classification therefore the Annual fee for Association Members is set as following:

1. **Severely indebted, Moderately indebted and Less indebted:** 40 euros
2. **Low-income, Lower-middle-income economies:** 100 euros
3. **Upper-middle, High-income economies and High-income OECD members:** 140 euros

Furthermore, we accept an Annual Fee Payment for the Associated members (individual members) following the same classification:

1. **Severely indebted, Moderately indebted and Less indebted:** 0 euros
2. **Low-income, Lower-middle-income economies:** 7 euros
3. **Upper-middle, High-income economies and High-income OECD members:** 15 euros

Resolution on Associated Membership (Individual membership) IAPSS General Assembly, Amsterdam 2006

Admitting that the relationship and contact between the Head Office and local members needs improvement

Believing that in addition to Association Membership, Associated Membership (individual membership) gives the possibility to develop a closer relationship between Association and its members

Stongly believing that the emerging need of individual membership creates a wider active IAPSS community

We agree that Associated Membership is also to be accepted in case of an already existing IAPSS Member Association within the individual's faculty

Resolution on the Activity of the Association Members IAPSS General Assembly, Amsterdam 2006

Wanting to increase the participation of the IAPSS members in the activities organized by the Association Members

Stressing the importance of announcing and inviting the IAPSS community to these activities

Believing that reciprocal inclusion of the members in each others' activities on the local, regional and international level, organized by the Association Members, will improve the network and the development of IAPSS

We request the Association Members to announce and invite all the members to at least one of their activities per year

We encourage the Association Members to publicize such activities through our means of

communication (mailing lists, web-site, newsletter)

Furthermore we encourage joint activities among the members

Resolution on Participation of the AC & GA IAPSS General Assembly, Amsterdam 2006

With the aim to clarify who can attend the AC & GA without paying the participation fee

Believing that all efforts invested in IAPSS should be rewarded

However admitting that the free attendance of the AC & GA by various active IAPSS bodies creates financial difficulties for the PAM to organize the event

We agree that free participation of the AC & GA is only to be granted to elected ExCom members, namely Chairperson, Treasurer, Secretary General and the three Vice-Chairpersons, who are living in Ljubljana, Slovenia, and to the first delegate of IAPSS Member Associations who are attending the conference
